The LTADD Regional Transportation and Highway Safety Committee met on Friday, September 27, 2019 at 11:30 am in the LTADD Board Room.

Chair, Judge/Executive Dean Watts (Nelson County) called the meeting to order at 11:30 am.

### **Opening Remarks**

Judge Watts welcomed all Committee members.

## **Minutes**

Judge Watts asked the Committee members to review the minutes from June 25, 2019 and asked for consideration of a motion to approve. A motion was made by Judge Maurice Lucas to approve the minutes as presented, seconded by Judge David Daugherty; motion passed unanimously.

#### **Approval Items**

The committee reviewed the existing RTC By-Laws as well as the RTC Goals and Objectives. The committee decided that only one change should be made in the Goals and Objectives, and that was to amend Objective 1A by removing language relating to the CRF metric, which is no longer used by KYTC. This was pointed out by Mr. Kevin Young with KYTC. For the by-laws, the committee decided no changes were necessary. A motion to approve was made by Judge Graves. A second motion was made by Judge Lucas to approve the items.

## **Discussion Item**

Mr. Bo Martin then began discussion about updates to the Annual Work Plan (AWP). Per the agenda, he discussed updates to the annual Bicycle Pedestrian Plan and discussed the issues of Major Freight Users (MFU's) and Major Traffic Generators (MTG's) with the committee. Mr. Martin explained that FY2020 was a major update year for both MFU's and MTG's. He explained that he would be reaching out to all judges in the region to ask for their assistance in compiling the MTG and MFU reports. Judge Watts asked that Mr. Martin include his current list of MTG's and MFU's in his request and Mr. Martin said he would include them.

Mr. Kevin Young gave the District 4 Update.

## Lunch

Judge Watts asked that the committee break for lunch at 12:00 Noon. Meeting resumed at 12:21 pm.

## **Discussion Item**

Judge Watts discussed the Western Bypass project in Bardstown. He stated that while KYTC had selected the "inner route" for construction, he wanted to ensure that the "outer route" would also be added to the CHAF database per his desire and also due to interest from Mayor Heaton (Bardstown) and Senator Jimmy Higdon. Kevin Young stated this wouldn't be a problem and that he would add the item into the CHAF database and further stated that no motion would be needed to do so.

#### **New Business**

A discussion then took place regarding Highway 605 in Nelson County. Judge Watts and Ms. Filiatreau discussed the portion of Hwy 605 between the Quick Stop and the Fire Station and a possible re-routing of Hwy 605. Both also agreed it would be good to improve the intersection at the bottom of the hill on Hwy 605 for safety reasons.

Judge Graves then asked Mr. Young about an issue in Washington County relating to combining two bridges that are very close to each other.

The next meeting was tentatively scheduled for December 18, 2019 in the Lincoln Trail ADD Board Room.
