The LTADD Regional Transportation and Highway Safety Committee met on Wednesday, August 18, 2021 at 9:00 am via Zoom Video Conference.

Chair, Judge/Executive Maurice Lucas called the meeting to order at 9:03 am.

# **Opening Remarks**

Judge Lucas welcomed all Committee members and guests.

# Minutes

Judge Lucas asked the Committee members to review the minutes from the meeting on June 14, 2021 and asked for consideration of a motion to approve. A motion was made by John Thomas to approve the minutes as presented, seconded by Judge Graves; motion passed unanimously.

# Approval Item

Mr. Bo Martin then provided the committee with the SHIFT 2022 Prioritization Plan for Lincoln Trail ADD. Mr. Martin explained that the document was mandated by KYTC and served as a narrative describing how and why regional projects were selected and boosted in the LTADD SHIFT 2022 process. After a review of the document, the committee approved the 2022

Prioritization Plan. The motion to approve was made by Daniel Carney and it was seconded by Judge Henderson.

### **Discussion Item**

Mr. Bo Martin then provided a brief overview of the SHIFT boosting process. With 15 boosts to distribute to 6 Counties, Mr. Martin recommended that each County receive 2 boost allocations, with the remaining 3 allocations to be decided upon by the committee with the help of KYTC District 4. After all committee members agreed to this boost allocation distribution, Mr. Martin led a discussion where each Judge Executive had an opportunity to discuss their preferred projects to boost. After some discussion among all Judges, with District 4 providing input on several projects, 15 projects were selected for boosting with 12 of those projects receiving a second boost from District 4 stated that two additional projects likely to be boosted by them as well.
