The unemployment rate in the Lincoln Trail District went up from 4.7% in October to 5% in November. LaRue County's 3.8% was the district's lowest jobless rate, while 5.6% in Marion County was the highest. The monthly sample of people drawing unemployment benefits showed that 35% had worked in manufacturing, 20% in construction, 18% in trade and 14% in services. ### 1997 KY Small Cities Community Development Block Grant Economic Development Program

### **TRADITIONAL**

Those projects which specifically address the creation of jobs for persons of low and moderate income through the provision of assistance to specific industrial and/or commercial clients

### NON-TRADITIONAL

Those projects that do not fall in the "norm" of typical economic development projects, but substantiate and address a need which is significant to the economic development efforts of the community. These projects will allow for the funding of eligible activities benefiting low to moderate income persons that may not directly relate to job creation, including but not limited to job training and placement or other support services including peer support, counseling, child care, and transportation.

### MICROENTERPRISE DEVELOPMENT

Those projects that are designed to assist in the building of capacity of local communities and community based organizations in developing and supporting microbusinesses. Microenterprise Development is defined as a commercial enterprise which has five or fewer employees, one or more of whom owns the venture. Eligible applicants must exhibit the ability to capitalize a microenterprise loan pool from revenue sources other than CDBG.

# The LTADD's Planner's Pulse

Kentucky's Scenic Highways & Byways

The Kentucky Transportation Cabinet's Division of Transportation Planning has set its next deadline for the Scenic Highways and Byways applications for March 3, 1997. The Scenic Highways and Byways program was established by the Intermodal Surface Transportation Efficiency Act (ISTEA) of 1991 with the criteria to be set by the States.

A Scenic highway or byway has roadsides or viewsheds of aesthetic, cultural, historical, and/or archaeological value worthy of preservation, restoration, protection, and enhancement. Scenic highways would be roads which meet the American Association of State Highway and Transportation Officials (AASHTO) guidelines for highways and are state maintained as part of the State Primary Road System. These roads would carry greater traffic volumes at higher travel speeds than the scenic byways. Scenic byways would be roads of lower traffic volumes and slower travel speeds. These byways would not necessarily be state maintained; however, safety of travel would be the prime consideration.

The Transportation Cabinet envisions a Scenic Highways and Byways Program based on strong local and/or regional support and commitment. Applicant groups are to unite public and private support and resources along the route. They are to prepare the application for designation of the route as part of the state scenic program. Applicant groups will have primary responsibility for the ongoing monitoring of the scenic qualities of the viewshed or adjacent land areas.

The Scenic Highways and Byways Program is a unique opportunity for government, private citizens and organizations through cooperative efforts to protect the state's natural scenic resources, promote tourism, foster associated economic development, and maximize the potential of little traveled or bypassed roads. COMPREHENSIVE PLANS COMPLETED

At its November Quarterly meeting, the Lincoln Trail Regional Planning Council reviewed newly completed Comprehensive Plans from Meade County and Nelson County. Both counties have experienced increased rates of growth during the past five years, and will be utilizing the planning process in order to accommodate such growth. Both county plans were endorsed by the Planning Council.

Meade County is beginning the planning process within the unincorporated portions of the county, as implementation steps are in the initial stages. Nelson County began organized planning over twenty years ago, and has learned many lessons along the way. They have a planning staff to implement their plan update.

The next Regional Planning Council Meeting will consist of a discussion regarding manufactured housing development issues. It is hoped that a representative from the Manufactured Housing Institute will present advances in the industry and how they fit into the existing guidelines. # Regional Transportation Committee Develops High Priority List

The Regional Transportation Committee has been working over the past few months to develop priorities for all unscheduled highway projects in the district. At a November 26 meeting, the committee developed a high priority list of projects. From the high priority list, the committee also developed a "Top Ten" list as required by the Kentucky Transportation Cabinet.

In order to develop this list, each county was given an opportunity to put its top priority on the list. The two remaining projects were filled by the ranking of a list of projects that have an overall regional impact. Those rankings were compiled by the LTADD staff with the top two being added to the "Top Ten" list.

Funding is once again available to Kentucky non-profits and local governments through the Affordable Housing Trust Fund (AHTF). The Trust Fund was created by the Legislature in 1992 to address critical housing needs for very low-income Kentuckians who are below 60% of the statewide median income. Funds are provided from the Commonwealth of Kentucky and the Kentucky Housing Corporation.

# AFFORDABLE HOUSING TRUST FUND Request For Proposals

The funds will be made available to local governments, housing authorities, nonprofit organizations and/or statewide housing assistance organizations on a statewide competitive basis. Projects will be selected based on area need, community cooperation,

willingness to serve very low-income persons, additional funds leveraged, construction costs, geographic distribution, permanency and affordability of housing and housing/services experience.

The Kentucky Housing Corporation (KHC) suggests all new applicants attend the application workshop offered on Tuesday, January 21, 1997 from 1 to 3 p.m. to discuss the application process. The application workshop will take place at the KHC St. James Offices in Frankfort. # LIFE SKILLS UPDATE

During the month of October, a Life Skills course was taught in conjunction with a dietary tray line training course held at Kentucky Technical Vocational School. The participants were all enrolled in the JOBS program. Attendance was high and consistent. Thirteen individuals received training on how to measure and prepare meal trays for individuals in nursing homes or hospitals. Along with job training, participants also attended the Life Skills course. Students were amazed at the amount of information they learned from the course, as well as how to apply what was learned to their every day lives. Several participants have gotten jobs using the skills learned in the Life Skills course.

In December, we held Certified Nurse Aide (CNA) training along with the Life Skills component. Participants who attended this training are still involved in the CNA training but had many good things to say about the Life Skills course. One participant wrote, "It helped me learn how to communicate with people better, ask better questions and to find out more about the job I'm applying for." Another comment made by a student was "I think I can make better choices in my life." All participants stated that they would recommend this course for anyone who was job searching. Everyone who does attend the course has a positive outlook on the future. With a little support and encouragement along with proper job training, we believe they can become self-sufficient, happy individuals.

# Open Houses Held

On December 12, 1996, the Work, Opportunity, and Resource Center in Leitchfield held its annual open house. The open house was attended by local officials, representatives from various local agencies, and the general public. Employment Specialist/Instructor Angela Jones did a fine job in preparing the facility and refreshments for the event. The Work, Opportunity, and Resource Center is a GED and Employability program serving Grayson County.

The Springfield Healthcare Training School's Annual Open House was held on Tuesday, December 17, 1996. The school has a holiday open house every year to show their appreciation for those affiliated with the school. This year's was a great success.

# JOBS Fair Held

The Lincoln Trail Area Development District JOBS program has been extremely busy during this A JOBS fair was held in Nelson fourth quarter. County on Tuesday, November 25, 1996, at the Kentucky National Guard Armory in Bardstown. Approximately 30-35 employers participated and all of them were looking for prospective employees. There were 300 people in attendance of which approximately 50 were JOBS clients. The Fair was a success, bringing the community together in a joint effort to make the public more aware of hiring practices. We are currently in the planning stages for the next JOBS Fair to be held in Hardin County during the first quarter of 1997.

We also held a Short - Term Training class in conjunction with KY Tech. The food prep class had eight JOBS clients enrolled and two of them were employed at the completion of the training session and three more clients have had interviews with prospective employers.



The Private Industry Council extends its congratulations to the Employment and Training Staff for the past year's accomplishments. In return, the council is proposing some new goals of its own for the next year. These goals are: to increase the percentage of PIC member attendance to 75%; be recognized at the JTPA Annual Awards again; have more alumni be recognized at the JTPA Annual Awards; Lincoln Trail Private Industry Council designated as the best PIC in the state; and meet all six mandated performance standards. A decision will be made on these proposed items at the next scheduled meeting on January 15th at 5:00 pm. The PIC is also in the process of filling vacant seats from the district.

# Cuts in State Aging Funds Impact Frail Elderly

In November, the Cabinet for Families and Children notified Area Development Districts statewide of an eight percent reduction in funds for the provision of Adult Day, HomeCare, and Supportive Services. For the Lincoln Trail District, this reduction amounted to \$75,390. With demand exceeding the availability of services prior to our reduction of funds, we will now be facing a much more severe waiting list, reduction in services existing clients are receiving, and a freeze on any new clientele.

For the past several years, we have been serving increasingly frail people with a minimum of services; reduction of any of this support will have significant impact on these individuals. As our population of elderly citizens continues to increase, our concern grows as to availability of resources to maintain the quality of life expected by all of us as we age.
