

Governor Patton Approves Transportation Enhancement Funding

Governor Paul Patton has approved more than \$7.1 million worth of Transportation Enhancement projects. The Transportation Enhancement program was developed through the Intermodal Surface Transportation Efficiency Act (ISTEA) of 1991 and was carried over in the Transportation Equity Act for the 21st Century (TEA-21). The projects being funded this year include museums, walking trails, civil war battlefields, and rock fences. The following Lincoln Trail Area projects were approved for funding:

- City of Irvington \$80,000 Pedestrian Enhancement Project Construction of sidewalks, curb, and guttering from the downtown area on KY 79 near the local bank and stretching approximately 3/4 of a mile to US 60 then another 1/4 of a mile to Hillview Drive. The project will provide access to downtown businesses and government services.
- Larue County \$60,000 US 31E Heritage Corridor Marketing Plan Development of a Master Plan for cooperative management of this historic road system now known as Highway 31E. The plan will be used to evaluate and inventory sites and develop recommendations for preservation, interpretation, and marketing. This is a regional project that also includes the counties of Nelson. Hart, Barren, Jefferson, Spencer, Bullitt, Allen, and Sumner County in Tennessee.

Mackville Community Center Receives NADO Innovation Award

The National Association of Development Organizations (NADO) provides training, information and representation for regional development organizations in small metropolitan and rural America. The association, a public interest group founded in 1967, is the largest and leading advocate for a regional approach to community. economic and rural development and provides a network for its members to share ideas and innovations, Since 1986, the NADO Innovation Awards Program has recognized organizations that demonstrate innovative approaches to economic, community and rural development. At its 33rd Annual Training Conference in Portland, Oregon, NADO awarded forty-nine 2000 Innovation Awards. One of the seven Innovation Awards presented in the "Health & Human Services" category was the Mackville Community Center project, nominated by the Lincoln Trail Area Development District. Mackville's project was recognized for its collaborations and partnerships in acquiring and renovating the school for use as a community center. The following is an excerpt from NADO's Economic Development Digest (July/August 2000):

After Mackville Elementary School was declared surplus property, residents organized Mackville Community Development, Inc. (MCD) and initiated efforts to purchase and renovate the school for use as a community center. With assistance from the Lincoln Trail Area Development District in Kentucky, the community of approximately 220 has raised \$130,636 and obtained a \$300,000 Community Development Block Grant. In March 2000, MCD acquired the property. The Mackville Community Center Project has engendered fellowship, civic pride and volunteerism, and is a model for rural communities facing the loss of significant community structures.

Washington County Judge/Executive and Mackville School alumni John Settles, LTADD Executive Director Wendell Lawrence, and LTADD Associate Director Janet Johnston attended the Innovation Awards Breakfast and Roundtable, and accepted the 2000 Innovation Award on behalf of the Mackville community at NADO's conference on September 12, 2000.

Five Lincoln Trail ADD Cities Receive R enaissance K entucky Designation

The Lincoln Trail Region had five cities that received Renaissance Kentucky designations at the Kentucky League of Cities Convention in Louisville on September 29. Communities are divided into designated tiers of bronze, silver or gold according to the program's criteria met upon application. Bardstown, Elizabethtown, and Springfield received silver designations and Bloomfield and Irvington received bronze designations.

The goal of Renaissance Kentucky is to recognize and honor communities that have maintained or restored their central downtown areas as safe, efficient and functional urban cores. Additionally, the program provides support and technical assistance with the development of strategies for those communities that want to improve their downtowns.

Renaissance Kentucky was launched by Governor Paul Patton in 1997, and 41 communities applied for and received this designation in 1998. During the last two years, these communities have received a total of \$32 million for infrastructure planning, streetscape and facade improvements and utility relocation.

"The concept of Renaissance Kentucky is working because of the successful partnerships being formed between state and local governments to return our downtowns to vibrant, healthy centers of activity," said Patton. "Through this redevelopment of affordable housing, retail and business centers and cultural opportunities in the heart of our cities, future generations will

reap the benefits of this initiative to restore our heritage."

Cloverport, Lebanon, and Vine Grove have been participating in Renaissance Kentucky since 1998 when each received a silver designation.

Regional Planning Council

The Regional Planning Council met on September 14, 2000, at Lebanon City Hall. This meeting was a great opportunity for planning commissioners and staff in the eastern part of the region to attend and participate. At this session, the 2000 update of the Lebanon Comprehensive Plan was presented to the Regional Planning Council.

Kentucky law requires local planning commissions to prepare and adopt a comprehensive plan to guide decisions regarding development within a community. The process for preparing and adopting a comprehensive plan is outlined by the State Legislature in KRS 100. The *Lebanon 2000 Comprehensive Plan* has been prepared based on these guidelines. The planning process included a population analysis, housing, economics, physical conditions, land use, transportation and other facilities. The plan also included a historical preservation chapter that highlighted the unique historical and architectural characteristics of areas and buildings in the City of Lebanon.

Bradfordsville Mayor David Edelen Wins Wal-Mart Award

Economic Development Grants in National Competition

WASHINGTON - The National Center of Small Communities (NCSC) has announced that David Edelen, Mayor of the City of Bradfordsville is the recipient of the American Hometown Leadership Award for outstanding leadership of America's smaller communities. Wal-Mart co-sponsors the award to promote strong leadership in small towns. Mayor Edelen received a grant in the amount of \$1,000 which he plans to invest in the Drye Corner Community Park

"The winners of the American Hometown Leadership Award demonstrate not only outstanding leadership qualities, but also the creativity and initiative needed to bring a measure of excellence to their work, " said Tom Halicki, Executive Director of NCSC. "Their ability to envision great things for their community, and their ability to translate that vision into action, makes them deserving of our highest honor."

Wal-Mart awards more than \$2 million annually in economic development grants to support local efforts to attract new business. This year, the company will award more than \$600,000 of these grants to more than 200 communities across the country through the American Hometown Leadership Award. The award recognizes outstanding civic accomplishments by elected officials who serve on a local government's board, council or advisory committee in a community with a population of 25,000 or fewer.

LTADD to Collect Road Centerline Data

The Kentucky Transportation Cabinet has contracted with the 15 Area Development Districts to collect road centerline data across the Commonwealth of Kentucky. The project will include both Geographic Information Systems (GIS) and Global Positioning System (GPS) and will be a 3-year effort.

LTADD recently employed Michele Walters as a GPS technician to collect road centerline data, and the ADD will utilize other Community and Economic Development staff members to complete the project. Starting in Fall 2000, the LTADD staff will begin collecting data in LaRue, Hardin, and Marion Counties, respectively. The staff will collect attributes for city, county, state, and federal road centerlines. The attributes were determined by KYTC and will include the following:

In order to earn the title of Certified Kentucky Municipal Clerk, a clerk must complete 100 hours of professional training through the Kentucky Municipal Clerks Institute over a three year period and be a member of the Kentucky Municipal Clerks Association for two years. Completion of this training allows city clerks and assistant city clerks to be eligible for certification at both the state and international level.

Simpson Creek Stewardship Project

For several years, the City of Bloomfield has wanted to utilize the area around Simpson Creek recreation. These desires have finally come to fruition with the submission and award of a Community Rivers and Streams grant. The City, working in cooperation with Bloomfield Community Tomorrow, will receive \$5,000 to assess recreational needs along Simpson Creek, hold a public forum, and organize and develop cleanups of Simpson Creek. Lincoln Trail ADD worked with the City and Bloomfield Community Tomorrow to complete and submit an application for the July 14 deadline.

Don't Forget Your Flu Shot . . .


Early fall is the usual time we think of getting our flu shot for the upcoming flu season. This year we are seeing a delay in manufacturing of the vaccine which will result in a 4 to 8 week delay in the availability. Kris Paul, Director of Nursing at the Lincoln Trail District Health Department, recommends that individuals get the shot when and where it is available. Some traditional sources of the vaccine may not receive it until much later in the season. We have been used to widespread availability of the vaccine and have seen shots offered everywhere from the senior center to the grocery store but this may not be the case this year. The Center for Disease Control recommends the following guidelines for vaccination:

*All persons over age 65

*Adults and Children with chronic disease (especially cardiovascular and pulmonary)

*Persons residing in long term care facilities

Employment & Training News

Rapid Response Activities

Approximately 350 people in **Nelson County** lost their jobs during this quarter when two Bardstown factories shut their doors. Within one month's time, both Bird Vinyl and Sumitok Magnetics announced closures. Representatives from both companies worked together with the Nelson County Fiscal Court, Bardstown Industrial Development Corporation, Nelson County Economic Development Agency, Department for Employment Services, and Lincoln Trail Area Development District to provide several activities aimed at helping the affected employees find jobs. These activities included:

- Outplacement was provided to Sumitok employees by the company. Services included resume writing, interview skills, job search skills, and other information helpful to dislocated workers.
- Four Rapid Response meetings were held for dislocated workers from both companies. Presentations were given by representatives of the Office of Training and ReEmployment, the Department of Labor, the Department for Employment Services, and the Lincoln Trail Area Development District. Eighty-three people attended these informational meetings.
- 3. A Job Fair was held on August 29, 2000, to benefit these employees but was open to any job seekers. Several employers were there, as well as representatives of area colleges and technical colleges, training programs, and financial programs. Copiers were provided so that job seekers could leave resumes with as many employers as possible.
- A grant has been awarded by the Blue Grass State Skills office to provide training services to employees of both industries.

The Open House was held in Chairman of the local Workforce Investment Board conjunction with the Kentucky Employer Council (KEC) meeting, allowing not only local employers but also employers from around the state to tour the Career Center. The KEC members, as well as other visitors, provided feedback from their tour of the Career Center, including the following:

- Not having agency affiliations on doors to staff offices tended to promote the feeling of partnership and "oneness."
- The assistive technology in the resource room that allows persons with disabilities full access to work registration and services was impressive.
- Having extended hours for customers who cannot take advantage of traditional government work hours will benefit both job seekers and employers.
- It was commendable that even while the reception and tours were being conducted, customers were still being served.

Welfare-to-Work (WtW)

Currently, the Welfare to Work (WtW) program is serving 112 people throughout the eight Lincoln Trail counties. On October 1, 2000, new WtW regulations will be enacted that will ease eligibility restrictions. Once the new eligibility requirements are in place, we expect to see an increase in the number of people entering the program.

During the past couple of months, plans and preparations have been made to begin enrolling Non-custodial parents. This group of people includes those who do not have custody of their children but still have responsibility for supporting them through child support payments. It is the hope of everyone involved with the program to assist members of this group in finding and keeping employment in order to meet the financial needs of their children.

Employment & Training Staff Conferences, Workshops, Seminars

During the July-September quarter, staff from the Employment and Training Section attended several beneficial and informative training seminars. First, on July 25, Julie Watson, Vivian Heath, Melanie Staderman, Mike Karnes, and Chris Hodge attended a one-day computer training in Lexington, Kentucky. The training focused on the Microsoft Office system and included lessons in Microsoft Word, Excel, and Works.

Next, from July 31 to August 2, Melanie Staderman, Mike Karnes and Chris Hodge attended an OMTI training in Columbus, Ohio. The training featured speaker was Greg Newton, who shared his thoughts and ideas on customer flow through the One-Stop system.

Last, from August 28 to 31, Sherry Johnson, Angela Nance, and Jackie Masterson attended a Region III, Workforce Investment Act Finance and Administration Conference held in Biloxi, Mississippi.

The Employment and Training Section said farewell to Michael Karnes on September 15, 2000.
