The LTADD Regional Transportation and Highway Safety Committee met on Tuesday, November 19th, 2024 at 9:00 am in the Lincoln Trail Area Development District Boardroom.

Judge Executive Maurice Lucas called the meeting to order at 9:04 AM (Eastern Time).

Opening Remarks

Judge Lucas welcomed all committee members and guests.

Minutes

Judge Lucas asked the committee members to review the minutes from the meeting on August 28th, 2024 and asked for consideration of a motion to approve. Motion was made by Judge Troy Kok to approve the minutes as presented, seconded by Jessica Filiatreau, motion passed unanimously.

Approval Items

The committee then partook in a discussion and review of the Committee Members List. Ms.Ava Oljeski provided the previous list and the members noted which names and contact info to change and or delete.

Discussion Item

A speaker presentation was given by Mr.Aaron Buckner along with walkthroughs of the grants the DOT website provides. The Committee discussed the applicableness of these programs to their yearly processes.

The Committee then began discussion of Major Freight User locations throughout the ADD district. Maps of known locations were handed out by Ms. Ava Oljeski to the committee. The committee took the time to review the locations and discuss any locations that they knew about. Additional locations identified were marked on the maps to be updated in the LTADD databases. Other committee members requested that they review a list/attribute table rather than a map.

The Committee later began the discussion of the Bike and Pedestrian Trail locations throughout the region. Maps of the known locations were handed out by Ms. Ava Oljeski to the members. The unidentified locations were marked onto the maps to be updated in the LTADD database.

Lastly, the Committee discussed the regional priorities of the current road project list. A packet was provided by Ms.Ava Oljeski in which the committee was asked to narrow down 24 projects to 5 but with the advisory of Mr.Daniel London the list was set to 8; totalling with one priority road project per county.
